SNHSA Judging Clinic - April 2 - with Tricia Booker

The SNHSA Member Education & Opportunities Committee is offering a special one-day Judging Clinic with Tricia Booker, co-author of the acclaimed "Judging Hunters and Equitation WTF? (Want the Facts?)" on Sunday, April 2, from 8:30 a.m. to 3:30 p.m. The clinic will be hosted at the Brownlee Equestrian, 1115 N Cantlon Lane, Reno, NV 89521.

The day begins at 8:30 a.m. with continental breakfast items, registration and introductions. Lunch will be at noon.

Beginning at 9 a.m., Tricia will speak of the history of Hunters and Equitation, judging basics, keeping a card, faults and scoring. There will be a PowerPoint presentation on judging Hunters and Equitation, with discussions on rider strategies to improve scores, with best practices for exhibitors.

The afternoon will feature video practice judging over fences classes (Hunter and Equitation), discussion of judging flat and under saddle classes, handy hunters, Hunter Derbies and Medal work-offs.

SNHSA strongly encourages riders of all ages to attend and expand their knowledge on how judging is done and why riders receive the scores they do when competing. SNHSA encourages parents to attend with their junior riders.

"We truly hope is that this information will help you better understand how we as judges work and think, how seriously we take the honor of presiding at a horse show, and how you, as an exhibitor, trainer, parent or fellow judge, might use this information in a positive manner to enrich your own role." excerpted from the Introduction written by Julie Winkel and Tricia Booker.

The first 40 registrants (junior with parent or adult rider) registering for the clinic will receive a leather notebook, courtesy of the SNHSA Board.

All attendees will receive a raffle ticket for a special item.
