



USHJA Nationals - Nov. 13-19, 2023

The **Marshall & Sterling Insurance/USHJA National Championships** are returning to the Las Vegas National, CSI4*-W, in Las Vegas, on Nov. 13-19.

NOTE: The deadline for submission of Declaration of Intent forms is now July 31

The Championships will feature the USHJA Affiliate Championships for Junior and Adult Amateur riders in 3 disciplines and 16 sections (2 added sections), along with many other National Hunter and Jumper Championships. Affiliate sections offered this year are:

- **Hunters 2', Children's and Adult, and Hunters 2'6", Children's and Adult**
- **Equitation 17 & Under 2', Equitation 17 & Under 2'6", Equitation 18 & Over 2'0" and Equitation 18 & Over 2'6"**
- **Children's and Adult Jumpers at 0.70m, 0.80m, 0.90m and 1.0m**

Horse and rider combinations may not compete in both the 2' and 2'6" Hunter sections. A horse and rider combination may be nominated for and compete in a maximum of two (2) divisions (Hunter, Equitation or Jumper). Horse and rider combinations may compete in a maximum of two (2) consecutive Jumper heights, but may be asked to compete in one USHJA Affiliate Jumper Section height lower or higher than the one qualified to compete. **Note new for this year:** Affiliate riders may not cross-enter into any rated sections, even on another horse.

As a USHJA Affiliate Organization, SNHSA will choose our most qualified horse and rider combinations for each division to nominate in 2023! As an affiliate organization, SNHSA is invited to select three riders for each section in order of preference, with the #1 rider guaranteed a spot. Riders #2 and #3 are not guaranteed entry as only 30 entries are accepted per section.

For SNHSA to know which riders to consider for selection, riders who are interested in being selected for 2023 are required to submit this **Declaration of Intent form** to SNHSA. SNHSA may offer sponsorships. If available, more information will be forthcoming.

As a part of SNHSA's selection process, the performance of horse/rider combinations in SNHSA divisions comparable to the Nationals Divisions will be included in their final selection criteria.

To be considered as a nominee for the USHJA Affiliate Championships, each horse/rider combination, their parent/guardian (if the rider is under 18 years of age) and their trainer will need to submit and sign a Declaration of Intent form along with a \$50 payment. The \$50 fee will secure the horse/rider combination's request to be considered.
