Rules

- Schooling is allowed Friday from 10 a.m. to 6 p.m. @ a fee of \$40/horse. **All riders must have a signed waiver release form.**
- **Entries are \$40/class for pre-entries, \$50 post entry late fee; warm-up rounds are \$40.**
- Management reserves the right to limit total number of entry registrations for a day/weekend.
- Riders and Trainers must be SNHSA members for Medal classes #117, #133
- There is a \$10/horse, non-refundable SNHSA/USHJA horse fee required by SNHSA and a \$25 SNHSA non-member fee is required for non-member riders entering SNHSA-sanctioned classes.
- **SNHSA requires that dogs be on a leash at all sanctioned events.** Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dog's behaviors.
- **Horses/ponies may not enter and show in more than six (6) classes in a day.**
- A \$30 non-compete horse fee applies - all riders & horses on property must have a signed release.
- Dry camp RV spaces (\$25/night) and overnight pipe corrals (\$40/night or day) are available. Contact Liz Lacroix at 775-781-9617.
- All cross-entry rules apply for classes entered. Please refer to the Rule Book available online at www.SNHSA.org for a complete set of rules.
- Proof of EHV/Flu Vaccinations within the past 6 months is required. Digital proof is preferred. Please send to Susan Howe at susanhowe@gmail.com with show registration forms.

^The Genesis Equestrian High Low Jumper Challenge is a speed round competition. Teams will consist of two riders, one competing at the “high” height and one rider at the “low” height. Professional, amateur and junior riders are welcome to compete. This class will run under the Table III with faults converted to seconds, with the first rider starting the clock as they cross the start line, and the second rider stopping the clock as they cross the finish line. For each rail down, four seconds will be added to the team’s time. There is no penalty taken for refusals, although two refusals per horse/rider team will result in disqualification.

The course will consist of no less than 12 fences with each rider jumping a pre-designated course at their height. The first rider, considered the Low rider, will jump their course first at heights not to exceed .75m. The second rider, considered the High rider, will jump their course after the first rider crosses the line. The High rider’s course will not exceed .90m in height. The second rider may ride around the arena anywhere they choose, but may not cross the start line for their course until the first rider has completed their course and crossed the finish line.

Riders may compete on up to two teams. Horses may compete on only one team. Ribbons will be distributed between first through sixth. The high riders may fill out a special declaration for points for Level 1 or Low Ch/Adult divisions.
