

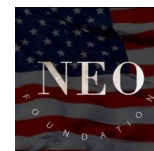

- Schooling is allowed Friday from 10 a.m. to 6 p.m. @ a fee of \$40/horse. **All riders must have a signed waiver release form.**
- Entries are \$40/class for pre-entries, \$50/class post entry; warm-up rounds are \$40. **Classes #114 and #118 have a \$50 entry fee.**
- Prize money for Stakes will be paid 50%, 30%, and 20%. Prize money will only be paid out if there are five (5) or more competing in the class.
- Management reserves the right to limit total number of entry registrations for a day/weekend.
- There is a \$10/horse, non-refundable SNHSA/USHJA horse fee required by SNHSA and a \$25 SNHSA non-member fee is required for non-member riders entering SNHSA-sanctioned classes.
- **SNHSA requires that dogs be on a leash at all sanctioned events.** Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dog's behaviors.
- **Trainers and riders must be 2024 SNHSA members for classes 230 and 241.**
- **Horses/ponies may not enter and show in more than six (6) classes in a day.**
- A \$30 non-compete horse fee applies - all riders & horses on property must have a signed release.
- Dry camp RV spaces (\$15/night) and overnight pipe corrals (\$30/night or day) are available. Contact Liz Lacroix at 775-781-9617.
- All cross-entry rules apply for classes entered. Please refer to the Rule Book available online at www.SNHSA.org for a complete set of rules.
- **Proof of Vaccination within the past 6 months is required.** Digital proof is preferred. Please send to Susan Howe at susanhowe@gmail.com with show registration forms.

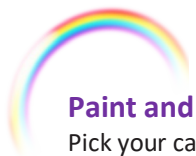

Table iii. Faults converted to time. Teams consist of two horse/ponies. The course will consist of 16 jumps, equally divided by two height groups. The competition will begin with the first rider competing at the 0.65-.75m height. They will jump their 8 jumps and hand the baton to the rider who is jumping the 0.85m height. The second rider will jump their 8 jumps. The first rider goes through the start line, the second/last rider goes through the finish line. If the baton is dropped, rider may dismount and pick it up and continue; the penalty is the time taken. Refusals are penalized by 4 seconds per refusal and the TEAM is allowed a total of 3 refusals before being eliminated. Rails count as 4-second time faults. The winner is the team with the best time and least amount of faults. Matching attire is encouraged.
